- 1. Meeting Duration 54 min., it began promptly at 8 p.m. EDT, Prez. L.F. completed roll call.
- 2. Secretary's Report:
 - a. The Minutes from the April 14 teleconf' were accepted as distributed.
 - b. Mike suggested that the Association identify a computer-wise person to be the "Media Manager". This individual can handle the every growing complex collection of video files, photos from members and reunions, scanned documents, and may become the keeper of the HDs we began using to collect these items. Instead of just reading his thoughts on this matter, Mike will send out a Word doc file that hopefully spells out where we are, what we have, and suggestions going forward. Larry said that four people are currently handling this, and we need a coordinator. Please respond to Mikes email. Also, Gus and Norm Evans have mission tapes that may be burned to CD for sale.  - c. Ev has an 18GB video file that will not fit on a DL DVD. No one yet has asked for their interview files Wayne verified we have not distributed any. We may use a Google Cloud based storage, but Wayne indicated that internet-security is an issue to be considered. Ev suggested we can use a 32G flash drive, but that will indeed mean cost increases. The Flash drives we already bought are only 8 GB.
- 3. Treasurer's Report, DW: Bank Acct. \$25,865, Quartermaster Acct. \$4145. Donation balance for Web: \$2019, do the math and the available balance is: \$19,716. PayPal is active still for the new Web Development.
