- 1. Meeting Duration 45 min, it began at 8:00 p.m. EST, VP LaRosa completed roll-call & officiated the meeting.
- 2. Secretary's Report (MD): Rev. 2 of the Minutes from the Apr 12, 2016 Telecom, were accepted as distributed.
- Treasurer's Report: DW Account balances, Primary \$26,638, Quartermaster Acct: \$2,158 Paid \$67.40 to PayPal & DreamHost

The "Pistol Raffle" has collected \$1,660 (one member bought 53 tickets)

- Reunion registrations: 17 are in, for a total of 33 people.
- 4. Quartermaster's Report GS Requests that the Association Golf Shirt be publicized in the May issue of the Firing Circle, & requests an account replenish from DW so he can reorder inventory. DW will transfer up to \$5,000 for Gus, & MD will include info/order form in the May Newsletter for Shirts. Gus rec'd an order via e-commerce for a video type but a detailed procedure is needed in order to get this followed through.
- Newsletter *Firing Circle* MD: Content for a May issue is 80% complete ACTION ITEMS: Mike needs from Doug an UPDATED "Who's Comin" list, & Gus asked that the registration form for the Fri Pensacola tour includes sending payment to Doug. MD affirmed it does. Gus cautioned that if we exceed 50 tour registrants, we will need another bus. Doug will track this & keep Gus informed when we near 48 tour registrants. MD will get the Firing Circle distributed in May.

 Website (IT Committee) Report, WL – Earl from TWE has 200 items up on the new Web site. The Alpha Roster is completed, & the next step is getting "test reports" from it for Board review – maybe as early as the end of this week (5/13/16).

Wayne has posted on the new Web site, every Association meeting minutes, agendas, & presentations that he has had available to him. This will be a big help to Association Historian Phil Deal with Association History. ACTION ITEM: Wayne & Mike need to review file naming convention so that there is no conflicts with the Website format.

ACTION ITEM: Gus needs to learn how to pull & inventory report from the e-commerce site.

The reunion coordinator report needs a macro to be coded, in order to pull the necessary info, & Earl is doing this now.

Ron inquired about the dBase process: It is completed (they had to manually enter 7 people that would not copy over), & we can now pull the Alpha Roster from it. It is NOT yet linked to the Web site. Wayne, Ron & Mike are the "change coordinators" for the MCL dBase.
