Conference was called to order by President Michael Drzyzga at 2000 hours:

Roll call was taken for those in attendance:

- 4. **Treasurers Report, Doug:** Operating account \$13,255.76, Quarter master account \$2.452.92, and Pay Pal account \$183.80 Totaling \$15,892.58. Refunds for the reunion may be approximately \$5,115.00.00, will have a more accurate figure once refunds are complete. Andrea made a motion to accept the treasurer's report with John Wolff second.
- 5. **Quartermaster, Gus**: The face masks are a new item; orders are coming in for them. Gus will be mailing out the 2020 T-Shirts that have been ordered. Next year's T-shirts will be the same, but possibly have on the back something to mark the Covid19. We did make \$562.35 for the T-shirts that were sold; Gus will deposit the monies into the Quartermaster account.
- 6. **By-Laws, Roy Davis**: Roy completed the Bylaws! They were distributed by Mike to the Board and Committee members for review. Vote was taken to accept the Bylaws as rewritten; all were in acceptance of the new and improved Bylaws. Wayne will update the Bylaws on the website. - 9. **Newsletter, Don:** Add Mike's Presidents message about the cancelation of the reunion. Ev, update on new members. Add Andrea's project message. Add Ev & Andrea's new email address. Notice for people to send to Ev copies of orders.
- 10. New/Old Business:

Reunion Video Project Andrea: There are 3,500. Pictures up in the google cloud, tons to look at. Forming a committee to create a presentation of past reunions. She will send email out asking a few key members if they would like to be on the committee.

Future Video Telecom: There would be a learning curve in using Zoom, MS teams etc. Is there a recording attracted to the program? What would be the cost?
