There are two factors in this necessarily long "we decline" response.

First, we've learned from feedback that our guys and their spouses are not as interested in Guest Speakers unless they are one of our own (actually in or involved in AC-119s). We've brought everyone we know of, who had an important piece of our AC-119 story, to reunions as a Guest Speaker. As we find more of our AC-119ers in our outreach efforts, we may find some additional ones. Until then, our Board decided not to include some very important and respected heroes as speakers (Bud Day, Gen Horner, several other well known POWs, Ken Carpenter - Sgt Levitow's AC, etc) and maintain the Association's focus on our AXC-119 heritage. With that in mind, we may not have "Guest Speakers" at our Reunion Banquets, and that's OK - in those cases the Prez might say a few words but not as a "Banquet Speaker". The second factor is sensitive, but to the Board and Association, very important. I discussed it with Gus and Craig and they agree.

The following is for you and the Board only (plus Bill and Tony as the Board's eyes, ears, and voice): Over the years, we've been fortunate to discover Sundog 29, Tom Milligan, who was the FAC flying Terry's wing that day. He came to one of our reunions, did a current FLIR technology presentation, and met with the Stinger 41 survivors. A couple years later, we found the A-1 driver, Lamar Smith, who provided fire suppression and was SAR leader for Stinger 41's crew recovery. In both those cases, everyone involved (the surviving crew, others who had been there that day, and the Stinger 41 families of those we lost) let us know there are aspects that would not serve anyone well and would possibly create problems for the crew and families. Terry heroically gave his life giving every one of his crewmembers the chance to live another day. That's what was (and is) important to the surviving crew, and they do not want to open that day up to any further presentations or reunion inclusions. It is still too much for many of them to relive and the Board unanimously decided to respect that.

The Board's Stinger 41 policy is that we will not send survivor/family contact info to anyone who was involved in that day's mission, SAR, or otherwise. We do forward messages from folks like Lt Gen Waskow if THEY initiate a contact request, and we leave it up to the respective Stinger 41 crew members and families if they want to respond to that contact. So far, that has worked well.

With those factors in mind, we very respectfully decline your offer to invite Lt Gen Waskow as a Guest Speaker. If HE wants to initiate contact with Stinger 41 survivors or family, we will forward his message to them, and they decide whether they'll respond (or not).

Lastly, the reason I'm the person responding, is because over the years I was directly involved in all the above, and the

Board and survivors asked me to be a "funnel" for any Stinger 41 contacts or info requests.

ALL, please keep this message only at the Board level, which includes Bill and Tony.

Mac, thank you for continuing to provide support and opportunities to the Association - please don't stop doing that!!!! Thanks! Wayne
