Thank you for the remembrance by James Whitcomb Riley. Allow me to share a story & poem with you. Just before Thanksgiving 2000, a gunship brother lost his 30 year old son. This young man had grown up with my children in California & Delaware. In grieving over this terrible loss, I was referred to a book titled "I wasn't ready to say goodby". Or something like that. In the book were a bit of prose & an old Hopi Indian prayer. Perhaps they will provide some more comfort to you these 30+ years later. I combined the two bits & have used them at eulogies for several lost friends & companions.

The first is the Hopi prayer.

"Do not stand at my grave & weep.

I am not there, I do not sleep.

I am a thousand winds that blow.

I am the diamond glints on snow.

I am the sunlight on ripened grain.

I am the Gentle autumn rain.

When you awaken in the mornings hush

I am the swift uplifting rush

of quiet birds in circled flight,

I am the soft stars that shine at night.

Do not stand at my grave & cry,

I am not there, I did not die."

The Prose was written by Antoine St. Expury, an aviation writer & reconnaissance pilot who was lost over the Med in WWII. He wrote, "In one of the stars I shall be living. In one of them I shall be laughing. And so, it will be as if all the stars were laughing when you look at the sky at night."

I never met you husband, but I know him as a brother & I, too, miss him.

"Thank you so much. I am very hurt that "powers that be" in that "Association" have treated my husband as "just dead," totally insulting in captions under his photos, Shadow, #11. They didn't even display those forwarded well in advance of the Reunion at the Memorial among all those others on display. And they just posted the photos in the last week or so without any relevance to respect for him or the distinction of his service as if "death" was IT!

I have that verse you referenced & have had it right here for years since I first read it in a column of Ann Landers. The closer I get to "that date & time," when I will be beside my "Major Mo" in Arlington, the more hurtful it has become that so many people I have encountered have such casual regard for the actual loss of those so wonderful .. our heart beats having been as one.. & to them, I can only extend condolences.

Hopefully, AWAY may have the same uplifting sense for others that feel the pain I have known since that 11th Day back in Oct of 1969. Even to see the picture of my husband is to know the wonderful man he was .. how caring .. & how loved he is by his family to this day .."

So far, the only place she's said some pretty hurtful things are in messages to Bill, Ev, Jim & me. I understand those hurtful messages are a reflection of the hurt she still feels, & as long as it stays out of the public eye, I agree with Jim that

we can & must just deal with it. But if she ever says any of those words in the website..... With that said, I think we also need to address this to the whole Board. Here's some thoughts I'd like to share with them - Bill sent this to us:

I now know why men who have been to war yearn to reunite. Not to tell stories or look at old pictures. Not to laugh or weep. Comrades gather because they long to be with the men who once acted their best, men who suffered & sacrificed, who were stripped raw, right down to their humanity.

I did not pick these men. They were delivered by fate & the U.S. Marine Corps. But I know them in a way I know no other men. I have never given anyone such trust. They were willing to guard something more precious than my life. They would have carried my reputation, the memory of me. It was part of the bargain we all made, the reason we were so willing to die for one another.

I cannot say where we are headed. Ours are not perfect friendships; those are the province of legend & myth. A few of my comrades drift far from me now, sending back only occasional word. I know that one day even these could fall to silence. Some of the men will stay close, a couple, perhaps, always at hand.

As long as I have memory, I will think of them all, every day. I am sure that when I leave this world, my last thought will be of my family & my comrades.....such good men. from "These Good Men" by Michael Norman

Those words really struck a chord with me.

- 1. Moses Alves WAS one of us one of *Those Good Men* & we cannot ever lose sight of that.
- 2. Our Association & Reunion is about *These Good Men*, & we must not allow our personal feelings to negatively impact the Association or its members.
- 3. At the same time, we cannot let our best get bashed without realizing the impact it has on them. Bill & Ev need to hear from the rest of the Board that they are some of the best examples of *These Good Men* in our Association, & I almost weep when I realize how they can be hurt by one spouse's angry, confused words. Teddi Alves may never realize the honor & respect we bestow on ALL of *These Good Men* including Moses Alves. Her concept of that is twisted by years of grief, loss, & pain that live behind a wall of anger for anyone not doing what she believes is needed. It does not matter to her that all the "good men" who were actually there understand & agree with *These Good Men*. She cannot see it & may never.

4 My concerns:

- The impact on Bill & Ev they need to hear from us that they epitomize These good men that they are not "at blame"
 that they have not done anything wrong.
- The impact on the Association, it's members, & other families who have lost loved ones <u>IF</u> Teddi puts anything on the web that are in some of her most bitter messages to some of the Board. The website & Guestbook must NOT become a place to blast anyone or anything. It cannot become a forum for anger, or bitterness.

I'd like to ask the Board to not respond. I want them to understand why – the only thing that can occur is bitterness, ugliness, hurt to good men, hurt to the reasons we're doing this (the Association, the Reunion, the Memorials), & hurt to the families who do not need this when they're just starting to get some positive feedback on the heroes we found in "Their Good Men". I'd like to re-affirm that we are working this & that any messages they receive need to come to us. As part of "what else can we do" I'd like to talk with Jim about getting Kevin in the loop – not against his mother, but at least not against us & what we've tried to do. I want him to understand our intent on how we deal with his mother.

With that said, one of the most difficult things for me to ask is can we put "Major Mo" on all his pictures. My request is not to identify him as "Major Alves" but by a nickname that perhaps many knew him as "Major Mo". It might stop the bitter attacks by Teddi & that is our goal. If we do this we eliminate one thing she hasn't let go of & it doesn't make the pictures a rank" issue — lots of the pictures include ranks. Doing this one thing might avoid any further lambasting.

So, LET'S TALK about some things like: a message to Bill & Ev (Cc whole Board); maybe some phone calls to Bill & Ev reaffirming their value; another message to the whole Board about not responding & why; a contact with Kevin (by Jim) to keep those lines of communication open; change the captions on Mo's pictures to Major Mo.

Whew....! Not what I wanted to spend a Sat doing but not something we can totally ignore. Thanks! Wayne

Mr. Terry was kind enough to let us know that you had posted the pictures, & our family is grateful for that kindness & memory of him. Also, as you would appreciate, Mo was extremely proud of his "Regular" status as he was an ROTC product & this was indeed an honor when extended to him on Aug 16, 1960, his Officer Commission as "Second Lieutenant," as of June 1957, Active Duty having commenced in Oct of 1957. Thank you again, Teddi Alves

Teddi Alves Second Message:

Whoa! A repeat? Sprous wasn't an "officer," & resents their "superiority?" I found this site I had located so long ago. Ho! Ho! Having had this lifetime "experience." Quoted below from your website, Sprous, the guy that wanted to develop the communication vehicle, "newletter," & did so most recently reducing Major Mo Alves to his surname in what was supposedly a report of a Memorial dedicated to him & others of AC 119 Gunships in Oct of 2003 having lost their lives in that pursuit in Vietnam, 17th & 18th SOS?

Now, at this LATE DATE, the WEBSITE POSTING of Captioned ID material relating to Major Mo Alves? "Glad to see the guest book back. The reunion was great. I felt like somewhat of an outsider as I didn't recognize many people. Also, it look like the Officers still place themselves above the enlisted guys for the most part. I am glad we decided to keep the reunion in Florida & have it every year. It looks as though our new association board will do a good job & carry us through the next year. I hope we grow & get the majority of flight & ground crew to join us. I will be back next year if the good Lord wills it. Thanks to all that worked so hard putting this reunion together. In a conversation this evening with our son, Kev, he expressed shared dismay, that although the pictures of Major Mo Alves, USAFR, who was killed in the crash upon takeoff for a combat mission when one of only two engines failed on Oct 11, 1969, had "finally made it to the website," several captions addressed him as "Mo Alves," sans "rank," as that of the most recent "newsletter" edited by Sprous, & other captions with more identifying information reduced him to a "Reservist" instead of Regular Air Force???? All related information had been supplied along with contact information inclusive of telephone number with submission of photos well in advance of The Memorial of Oct of 2003.

To add insult to injury in that photos of Major Alves supplied well in advance of "the Reunion of 2003" were not deemed "suitable" for display at "The Memorial" supposedly to him & others killed in service in the Gunships among those others displayed prominently & in abundance at "The Hootch," our granddaughters visibly distraught, only in the last few days did they appear as described above with captions appear on the website of the AC 119 Gunship Association???Mr. Terry has so extended himself to our family that he has become one of us. I have to wonder how deliberate have been the really hurtful failures to show a modicrum of respect for Major Mo Alves & his entire family having responded to the "Marque" promotion of respect for all those of crews of The AC 119 Gunships that was to be shown to families of All of Those Having Lost Their Lives in the Service of Gunships, & for this family having incurred serious personal & financial costs for such participation in good faith?

It simply defies belief that there could be such lapse of protocol & basic respect for memories & sacrifices of those you purported to honor as names memorialized on that "Memorial" dedicated at the "Reunion" of 2003. Not only did Major Mo Alves USAFR have an early interest in "flying," he wanted to explore how "one does that?" And beyond that, "how do you develop missiles that launch & "do the job?" Airplanes & aerodynamics of same underlying basics. Somewhat different in perspective than "catching a ride" on the next "flight!"

I have sent an email to Major Archy [Charles] & haven't had a reply to date, & I had wondered if he had attended any of the reunions to give me an idea of the program & so forth, as well as attire. Our son resides in the Tampa area, but he just took his vacation, & there is a complication in terms of my typical visits when he is on vacation, which would next be at Christmas, but it is likely we will try to attend, & I hope we will be able to be there together.

I don't like to see my husband's name without his rank & branch of service as he was both a regular & career officer, & also his name among his friends, was "Mo," even "Major Mo." It is a respect due him & well earned. You may not be aware that Mo was an Air Force Development Engineer & had been Program Director for Re-Entry Systems, Minuteman, Air Force Space & Missiles System, & was to be reassigned upon completion of that tour in Vietnam.

He had his BS in Aeronautical Engineering from Rensselaer Polytechnic Institute in Troy, NY, 1957, where he had been president of his fraternity, & was commissioned from Air Force ROTC. He was subsequently honored by the invitation to accept a regular commission, & this followed by his assignment to The Air Force Institute of Technology where he was awarded his graduate degree in Aerospace Engineering in 1966, his thesis having been, "A Study of Manned Vehicle Reentry From Hypberbolic Velocities."

In his early career, Mo excelled as a Navigator/Bombardier on a B-47 crew, & served at that time in the same squadron with Major Archy, who was also his classmate at AFIT. Suffice it to say that Mo would have had at the instant a complete comprehension of that Gunship & all issues related to design capacity "& flight."

I will be forwarding pictures in any event & contacted Sgt Petrie as well. I would hope that bio related to Mo would include his very stellar career, his wonderful parents who immigrated from Portugal when he was but three years old, his older brother having been a prison of War in WW II for five years.
